The People of the State of New York, to *Peter Westland, Collector*
of the Town of *Montz*, in said County of Cayuga:

You are hereby commanded to collect from the several persons named in the Assessment Roll, to which this Warrant is annexed, the several sums mentioned and set down in the last column of the said Roll, opposite to their respective names; and you are hereby authorized, in case any person named in the said Assessment Roll, shall refuse or neglect to pay his tax, to levy the same by distress, and sale of the goods and chattels of such person. And you are hereby commanded to collect the sum of fifty cents from every person appearing, by the said Assessment Roll, liable to pay the same. And you are hereby further commanded, where the name of any person between the ages of eighteen and twenty-one years, shall appear on said roll, to collect the same of the father, master or guardian, with whom such person shall reside, or out of any property such minor may have in said *Town* of *Montz*, and you are hereby directed and required, on or before the first day of February next, out of the moneys so to be collected, to pay to the Commissioner of Highways, of the said town, the sum of *25.00*, and also the moneys raised therein to defray any other town expenses, and to be paid to the Supervisor of said town. And you are further directed and required, on or before the said first day of February next, to pay to the Treasurer of said County, the residue of the said moneys, so to be collected.

Issued under the hands and seals of the Board of Supervisors of said county, (or a majority of them,) at *Albion* the *3^d* day of *December* in the year of our Lord, one thousand, eight hundred and *fifty-one*.
